

## **CRITERIA OF ELIGIBILITY FOR ADMISSION UNDER MANAGEMENT QUOTA**

Admission is offered only to eligible candidates as per prevailing University norms and Council of Architecture norms

- Candidate must be a citizen of India
- Candidates who have passed 10+2 or equivalent examination with Physics and Mathematics as compulsory subjects along with either Chemistry or Biology or Technical Vocational subject or Computer Science or Information Technology or Informatics Practices or Engineering Graphics or Business Studies with at least 45% marks in aggregate or passed 10+3 Diploma Examination with Mathematics as compulsory subject with at least 45% marks in aggregate.
- The candidate shall have a valid National Aptitude Test in Architecture (NATA) score.
- The Candidate shall have completed 17 years of age as of the last date of submission of the application form.

The candidate fulfilling the above criteria shall fill the Application 2025-26 available on the website **[www.mescoa.com](http://www.mescoa.com)**.

### **HOW TO APPLY**

Application for B.Arch Admission for 2025-2026 of MESCOA shall be made online only. Applicants are advised to go through the Information Brochure before making the application.

## IMPORTANT POINTS TO BE NOTED BEFORE REGISTRATION

Before applying online, candidates should-

- (i) make the payment of Rs.1000 towards application fee to the bank account given below

## GUIDELINES FOR SCANNING AND UPLOAD OF DOCUMENTS

Before applying online a candidate will be required to have a scanned (digital) image of his/her photograph, signature, transaction receipt as per the specifications given below.

Photograph Image:

- Photograph must be a recent passport style colour picture.
- Make sure that the picture is in colour, taken against a light-coloured, preferably white, background.
- Look straight at the camera with a relaxed face.
- If you wear glasses make sure that there are no reflections and your eyes can be clearly seen.
- Caps, hats and dark glasses are not acceptable. Religious headwear is allowed but it must not cover your face.
- Dimensions 200 x 230 pixels (preferred).
- Size of file should be between 50 KB–500 KB
- Candidate should also ensure that photo is uploaded at the place of photo and signature at the place of signature

Signature:

- The applicant has to sign on white paper with Black Ink pen.
- File type: jpg / jpeg

- Dimensions: 140 x 60 pixels (preferred)
- File Size: Between 20 KB – 500 KB

Transaction Receipt:

- File type: jpg / jpeg
- File Size: Between 50 KB – 500 KB

### **APPLICATION REGISTRATION**

1. Candidates to go to the MESCOA website ([www.mescoa.com](http://www.mescoa.com)) and click on the option "APPLY ONLINE" which will open a new screen.
2. Candidates are advised to carefully fill and verify the details filled in the online application
3. The Name of the candidate should be in block letters and spelt correctly in the application as it appears in the Certificates.
